

## Materials Use Agreement

As a participant in a course offered by Duke Integrative Medicine (Duke IM), I understand that I will be provided with materials developed by Duke IM. I understand that the materials are the Intellectual Property of Duke IM and are subject to revision, change, or discard at any time and that there will be no notice to me of such actions.

Duke IM grants Licensee (Individual) a non-exclusive, perpetual, revocable, license to use the following Licensed Material:

- Wheel of Health
- Personal Health Plan Manual
- Personal Health Plan
- Personal Health Inventory
- Goal Setting Guide
- Coaching Session Prep Form
- Client Consent Form
- Sample Information on Integrative Health Coaching

The specified Licensed Material may only be used by the Licensee for the provision of services to individuals or group coaching clients/patients. I understand that the Licensed Materials are provided as educational tools, and that Duke IM does not know whether they are suited to use with any particular client/patient of mine or in any specific situation with which Duke IM is not directly involved. Licensee, as an Individual, cannot use the Licensed Material to teach in other coaching programs.

Licensee will not modify or sublicense any of the rights granted. Copies of the Licensed Material created or transferred pursuant to this License Agreement are licensed, not sold, and Licensee received no title to or ownership of any copy of the Licensed Material itself. Duke University is the owner of the copyright to the Licensed Material. Licensee may not alter copyrighted materials in any way.

For whatever purpose I use the Licensed Materials, I agree to indemnify, defend, and hold harmless Duke University and Duke University Health System, its governing board, officers, employees, and agents from any claims, suits, cause of action, costs, damage, or expense of any nature arising out or in any way connected with my use of the Materials.

Granting this non-exclusive license does not imply support, endorsement, sponsorship, or affiliation with Duke IM or any other program of Duke University or Duke University Health System, Inc. As such, the Licensee will not state, in writing or orally, an affiliation with Duke IM or any other program of Duke University or Duke University Health System, Inc. For example, it is not acceptable to include a statement such as, "Duke Integrative Health Coach" or "Duke Integrative Medicine Health Coach" on a website, email, or other professional materials.

Licensee may include in descriptive materials an appropriate statement reflecting their completion of a course offered by Duke IM. For example, upon completion of the IHCPT Foundation Course, it is acceptable to include a statement such as, "Completed the Integrative Health Coach Professional Training Program Foundation Course at Duke Integrative Medicine" or to use the title "Integrative Health Coach." Upon completion of the Certification Course, including passing the oral exam, it is acceptable to include a statement such as, "Certified Integrative Health Coach through Duke Integrative Medicine" or to use the title "Certified Integrative Health Coach."

As IHC is not an academic credential or licensure, it is not acceptable to display "IHC" or "CIHC" or other similar titling credentials in an email signature or on other professional materials such as business cards, brochures, websites, etc. For example, it would not be acceptable to say, "Henry Jones, IHC." It would be acceptable to say, "Henry Jones, Integrative Health Coach."
